CONTRIBUTOR CHOICE – SPECIFIC AGENCY OR UNITED WAY Contributor Choice Eligibility Criteria: In order for an agency to be eligible for the Contributor Choice program, the agency must be in compliance with the USA PATRIOT ACT and all other counterterrorism laws; must have an IRS 501(c)(3) tax-exempt/ tax-deductible status; must be in full compliance with all federal, state, county and local requirements and laws pertaining to non-profits; meet the requirements of the Solicitation of Funds for Charitable Purposes Act passed by the Pennsylvania Legislature in 1990; and should be setup to receive ACH deposits. United Way contracts with a third party vendor to validate agencies against the IRS Publication 78, the terrorist watch list and 990 revocation list on a monthly basis before agencies receive a payment. A fee will be charged on all contributions to reimburse UWSWPA for fundraising and processing expenses incurred. Pledges and designations are valid for one year only.
